Import Financing

We arrange Letters of Credit, enabling you to initiate orders without the risk of advance payment. Only when your order is shipped per your instructions, do funds actually change hands. You can also arrange banker's acceptance financing and working capital loans if you need to warehouse or sell imported inventory.

Export Financing

To reduce your risks of selling in foreign markets, Touchmark guarantees payment to you either by confirming your buyers' Letters of Credit or discounting your drafts drawn from a buyer's LOC.

Pre-Export Financing
